

## ACKNOWLEDGMENTS

This book presents a set of arguments first articulated in my Ph.D. dissertation submitted to the Department of Government at Cornell University in 1998. These arguments have since been more firmly grounded in theory and history alike, as is most evident from the addition of an entirely new chapter (chap. 2). Serendipitously, they have also benefited from a “reality check” of sorts, as the second “People Power” revolt to oust a Philippine president unfolded during my research sabbatical in 2000–2001 (see especially chap. 8). The book is based in large part on research conducted in the Philippines during the course of a decade (June–August 1990, June 1991–November 1992, January–March 1994, and August 2000–January 2001). The sources of inspiration, support, and guidance have been many, as have the forces of distraction and diversion along the way.

To the members of my Special Dissertation Committee at Cornell I owe many thanks for constructive support and rigorous criticism throughout the various stages of the dissertation and, indeed, throughout the formative years of my becoming a political scientist, of a kind. In this regard I thank Sidney Tarrow, who as my teacher and committee chair not only introduced me to the social movements literature, but also tirelessly encouraged and debated my own somewhat unorthodox engagement with such scholarship. Surely my turn to the writings of Antonio Gramsci is also a “citation” of sorts to Sid, whose earlier work on Italian politics and society offers much food for thought.

To Benedict Anderson I am thankful for nudging me along with probing questions and detailed comments in the course of researching and writing. Thinking back on old wrinkles and new moves in successive draft chapters of dissertation and book manuscript alike, I gratefully recognize the lasting influence of his perceptive insights into Philippine politics and society. To Peter Katzenstein I am grateful for challenging me to reconsider things transnational—both in my own research and in the literature. Years after “defecting” from “IR” I remain full of appreciation for his generous advice and support. To Jonas Pontusson I owe some of the earliest inspirations for this book. Over the years he also prompted more serious and systematic attention to modes of critical and comparative analysis without which this book would have been decidedly duller.

To those who made field research in the Philippines possible, rewarding, and enjoyable, I would also like to record my debts. Under the stewardship of Randolph David, Alex Magno, and Miriam Coronel Ferrer, the Third World Studies Center at the University of the Philippines (UP) at Diliman graciously hosted me as a visiting fellow from June 1991 until November 1992 and again from August 2000 until January 2001. At the center, Macaria “Caring” B. Francisco and Bienvenida “Bien” C. Lacsamana deserve special mention for their steadfast supply of local knowledge and delicacies. At another regular port of call, the Lopez Museum in Pasig, I benefited from resident archivists Elvy I. Remedio’s and Mercy B. Servida’s expert navigation through an unusual newspaper and magazine collection, as well as their good company and *merienda* during frequent electrical power failures in 1992. It has been an inspiration and a privilege to follow the extraordinary travails of the Institute for Popular Democracy, and I am especially grateful to Eric Gutierrez and Joel Rocamora for their generous advice over the years. I also thank Sunny Benitez and Jim Rush for introducing me to the Ramon Magsaysay Award Foundation in Manila, where helpful staff facilitated my research into the Magsaysay Papers. Beyond UP and Ateneo de Manila University in the metropole, the following institutions also made available their local newspaper holdings: University of San Carlos in Cebu City, University of San Agustin in Iloilo City, La Salle University in Bacolod City, Xavier University in Cagayan de Oro, Ateneo de Zamboanga College in Zamboanga City, and Ateneo de Davao University in Davao City. If such contacts and archives provided useful points of entry and departure, the encounter with a few key NAMFREL organizers in a single municipality became the real crucible of my field research in the early 1990s. Thanks to the gregarious enthusiasm of Rafael “Apa” Ongpin, I met with Mrs. Mariabel Ongpin, a formidable force behind NAMFREL-Mandaluyong in Metro Manila in the mid-1980s. Through the helpful introductions of Mrs. Ongpin I also gained initial access to people and organizations closely involved in coordinating and mobilizing NAMFREL support locally, from business, community, and church leaders to their followers among office workers, housewives, and out-of-school youths. In keeping with the expressed wishes of those interviewed, I have made no attempt to conceal individual names and organizational titles when referring to these interviews.
