Civil Affairs Information Guides and Civil Affairs Guides are designed to aid civil affairs officers dealing with problems in liberated areas, each guide being focused upon a specific problem in a particular area. These guides are not basic collections of factual information, as are the Civil Affairs Handbooks, nor are the recommendations contained in the guides intended to take the place of plans prepared in the field. They are rather designed to point the factual information toward the making and executing of plans by those civil affairs officers assigned to this work in the theaters of operation. *In no sense is a Guide to be taken as an order.* Such orders will be issued in the normal manner. This Guide has been approved by the Committee on Civil Affairs Studies.
