

Verzeichnis der Deutschlandanalysen der R&A-Branch und ihrer Nachfolgeorganisationen im Department of State

Hier sind nur die für die vorliegende Arbeit ausgewerteten Deutschlandanalysen verzeichnet; die von R&A für das War Department ausgearbeiteten Civil Affairs Guides sind in einem gesonderten Anhang aufgelistet und hier nicht erfasst. Der Seitenumfang ist nicht für alle Studien angegeben, was z. T. die noch uneinheitliche Aufnahme während des Anfangsstadiums der Forschungsarbeit reflektiert, z. T. aber auch darauf zurückzuführen ist, daß gerade die umfangreicheren Arbeiten – besonders wenn sie Entwurfscharakter haben – nicht immer eine durchgängige Seitenzählung aufweisen. Studien über wirtschaftliche und territoriale Fragen enthalten zudem häufig umfangreiche Statistiken bzw.
