Like many first books, this one grew out of a doctoral project that I completed while doing a PhD at McGill University. It took a community to produce that earlier work. I have many individuals and institutions to thank, and it is my great pleasure to mention some of them here. I cannot thank enough my professors, peers, friends, and extended family. I had the greatest fortune of drawing on the advice of Axel van den Berg, who not only supervised my research but also guided my childlike sense of wonder when I was trying to learn everything all at once. Being an outspoken defender of McGill University Sociology Department's "Ho, ho, not so fast" approach to social change, Axel taught me how institutions never, ever change overnight. My training-through-research with Axel also taught me, among zillions of other things, how I could develop my passionate persona in writing. At McGill, I also benefited immensely from long conversations with Donald von Eschen, Kari Polanyi Levitt, and Michael Smith on economic sociology and political economy. When it came to European studies, it was Barbara Haskel who served as the *pôle*. I was very fortunate to carry out fieldwork at the Institut d'études européennes at the Université Libre de Bruxelles (ULB), on Barbara's initiative, as part of the EU-Canada Transatlantic Exchange Partnerships Programme.

My continued interest in the political economy of the euro was only possible thanks to two institutional entrepreneurs who were extraordinarily generous to graduate students in ways more than one: Amy Verdun, who created the European Studies Program and everything to do with it at the University of Victoria, and Jane Jenson, who not only built the Université de Montreal/McGill University Institute for European Studies but was also the centre of gravity for European studies in Canada. Amy and Jane, being their resourceful selves, did everything to help my research be not only possible but also less austere at the ULB's

Institut d'études européennes, the Max Planck Institute for the Study of Societies in Cologne, and the Zentrum für Sozialpolitik at the Universität Bremen. My earlier work would not have been possible without their exceptional generosity and constant encouragement.

Philippe Pochet was another institutional entrepreneur, one who had built the Observatoire social européen in Brussels, a Mecca for anyone working on the social dimension of the euro. Philippe was extraordinarily generous with all kinds of resources when he hosted me at the Observatoire during multiple stages of my earlier work. He has been a role model with his open-mindedness to being proved wrong as new evidence contradicts one's research.

While it took a community to complete my doctoral project, it took another to revise it for this book. My interest in the political economy of the euro had peaked when I stumbled on Kenneth Dyson's *Elusive Union* (1994). Kenneth's work was truly an inspiration for an economics master's student interested in the political construction of the euro. The only downside about my conversations with Kenneth was that I met him only after having completed my research at McGill. I never stopped learning from reading and re-reading his work. Kevin Featherstone was probably one of the kindest, alongside being one of the most insightful, discussants I could have ever dreamt of having on my conference panels. I could not have learned more from observing how gentlemanly and genuinely Kevin engages with the individuals around him.

I do not think I would have invested so much time and energy on the impact of monetary integration on Europe's welfare states had Andrew Martin and George Ross not produced the inviting exemplary work on it. I remember, while at McGill, savouring every tiny little research note on the euro that these pioneering Europeanists had written, collectively and individually. The power of their work inspired my research and this book. I was very fortunate to meet George Ross at the Université de Montreal/McGill University Institute for European Studies events just before I completed my PhD. I met Andy only later, while I was a visiting scholar at the Minda de Gunzburg Center for European Studies at Harvard University. I learned so much from their work and my conversations with them. My debt to Andy and George for all this is immeasurable.

The formative ideas in my research had been significantly shaped by the work of Peter Hall. I had read *Governing the Economy* (Hall 1986) for the first time when I was taking a graduate course in economics at METU, and it showed me that there was an entirely different world out there on the comparative political economy of economic policy choice beyond my usual reading lists. It was through Peter's work that I finally

put my mind to studying ideas, interests, and institutions in a wider social science perspective. I felt blessed to have conversations about my work with him at Harvard's Center for European Studies after being influenced by his work for so many years.
